AN ORDINANCE DECLARING THE RESULTS OF A SPECIAL ELECTION HELD IN THE CITY OF WARRENSBURG, MISSOURI ON TUESDAY, APRIL 2, 2019.

WHEREAS, a special election was held in the City of Warrensburg, Missouri on April 2, 2019 for the purpose of submitting to the voters approval of an ordinance adopting a lodging tax.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WARRENSBURG, MISSOURI, AS FOLLOWS:

Section One.

It is hereby declared and ordained that the results of this special election show that a majority of those voting in the election approved and favored the imposition of a five percent (5%) lodging tax pursuant to Section 67.1000 RSMo and that the Council has canvassed the return of said election and certifies that the results are as follows:
