A meeting of the Warrensburg Convention and Visitors Bureau Visitor Center Committee was held via Zoom on Wednesday, July 6, 2022, at 9:03 a.m.

Roll was called as follows:

The adoption of the agenda was considered. Whitworth made a motion to adopt the agenda as presented. The motion was seconded by Phelps. Motion passed.

Minutes from the Wednesday, May 25, 2022, committee meeting was presented for approval. Phelps made a motion the minutes be approved as presented. The motion was seconded by Whitworth. Motion passed.

The 407A East Russell Ave; St. 2 property was discussed. The director noted they are working to get confirmation from Mike Keith Insurance they have updated our policy to reflect the moves. CAM charges for the second quarter (April and May) have been received and processed.

The 200 S Holden property was discussed. Everything is going smoothly, and we appreciate the City's support in allowing us to occupy the space.

The 205 N Holden property was discussed. The layout of the upper level and lower level provided by the architect was presented. Minimal renovations will be made to the upper level. The several of the projects on the upper level will be done out of safety concerns so the space can be utilized and properly maintained.

The director provided an update on Goal 1 (Visitor Center) on the WCVB strategic plan.
